#### **Terms & Conditions:**

- 1. All bidders must submit the following documents along with the tender:
  - 1. A copy of the PAN Card.
  - 2. A copy of the Valid Trade License.
  - 3. A copy of the GST Registration Certificate as applicable.
- 2. Court Fee Stamp: The bidder must affix a Court Fee Stamp of Rs. 8.25/- or more.
- 3. **EMD:** The bid document must be accompanied by the Earnest Money Deposit of Rs.10,000/- (Rupees Ten Thousand) only in the form of a demand draft in favour of Assam Electronics Development Corporation Ltd. payable at Guwahati.
