The detailed scope of work and qualifying criteria of the bidder are specified below:

### **3.1.** Brief Scope of work - Deliverables:

Bidders needs to Supply, Install, Integrate, Commission and Maintain 2503 nos. of IRIS (**Iris Recognition Immigration System**) Scanners at designated locations in Assam as per the minimum technical specifications indicated in this tender document. The supplied IRIS Scanners should carry a 60 months comprehensive onsite warranty from the date of acceptance sign-off on its hardware and associated software. The selected bidder will also be responsible for maintenance of the supplied IRIS scanners.

Bidder has the responsibility to integrate the proposed Iris Scanner with the existing ePOS device against each FPS at designated locations.

- 3.5.2. Delivery shall be deemed to have been completed after handover of the product installed and commissioned in the DHQs/SDHQs. Service Engineer/representative of bidder shall have to be present during installation/service/re-installation of the products at the school.
- 3.5.3. AMTRON reserves the right to settle matters regarding the designated FPS of delivery of products to be supplied by the bidder(s) who is/are awarded the supply order(s) during the process of finalization of the supply order.
- 3.5.4. All designated FPS shall be in the state of Assam and shall be duly notified by AMTRON/Commissionerate FPDCA&LM, Assam/ District Authority, FPD&CA.

## **3.6.** Post Delivery Inspection and Acceptance Sign-Off:

- 3.6.1. The selected bidder shall depute its technically qualified representatives for commissioning / installing the delivered quantity of IRIS Scanners, in presence of the Nodal Officer, at all designated locations as per work order/ contract.
