## **Scope of Work:**

The Union Cabinet headed by The Prime Minister approved the proposal of Department of Telecom (DoT) to proliferate Broadband through Public Wi-Fi networks under the framework of the Prime Minister's Wi-Fi Access Network Interface (PM-WANI).

Assam Electronics Development Corporation Ltd. (AEDCL), a Govt. of Assam undertaking is initiating a project to deploy and manage PMWANI WiFi hotspots across the state of Assam. This project aims to provide internet access to educational institutions, public health centres etc. enhancing digital connectivity and fostering digital inclusion through compliance with the PM-WANI framework.

As per directives received from Govt. of India for deployment of Public Wi-Fi under PM-Wani framework, Assam Electronics Development Corporation Ltd (AEDCL) intends to deploy Three thousand (3000) PM-WANI compliant WiFi access points across the state of Assam. This is a new framework for proliferation of Broadband through public Wi-Fi network namely Prime Minister's Wi-Fi Access Network Interface (PM-Wani).
