#### I. Brief Scope of work:

The selected Contractor shall be responsible for the Supply, Installation, Commissioning and Construction of TEXMIN-AMTRON CPS 4.0 Center of Excellence within the Existing 3DPCOE at Tech City, Guwahati, Assam within the stipulated time. In the existing Ground floor of the 3DPCoE (G+1) RCC building approx. 1040 Sqft area reserved for the Set-up of TEXMIN-AMTRON CPS 4.0 Center of Excellence. The Contractor shall also be responsible for periodic assessment and framing the strategy for successful completion of the project.

#### II. Procurement of RFP:

#### **III. Tender Processing Fees:**

A non-refundable fee of Rs 20,000/- (Rupees Twenty Thousand Only) shall be made towards the cost of tender processing fee through Internet Banking from State Bank of India (SBI) or any other banks listed at SBMOPS on <a href="https://assamtenders.gov.in">https://assamtenders.gov.in</a> or NEFT/RTGS in case of offline payment from any Bank.

The Tender document Fees in any other form shall not be entertained.

#### IV. Eligibility Criteria:

### A. Qualification Criteria

- 1. The Bidder should be a private / public limited company or partnership (including LLP) / proprietorship firm and should be in existence in India for a minimum period of five years as on the Bid Due Date. Individuals are not eligible to participate in this RFP.
- 2. Participating in the bids should have had a minimum Average Annual Turnover of 1.5 Cr. in last 3 Financial Years (FY 2022-23 to 2023-24 to FY2024-25) from duly supported by Audited Balance Sheets.
- 3. Company should have positive net worth in last 3 Financial Years (FY 2022-23 to 2023-24 to FY2024-25) duly supported by Audited Balance Sheets.

- 4. The Bidder should not be blacklisted by any Government Department, Organization, Corporation, or any other body.
- 5. Bidder must have to submit the Manufacture Authorisation Form for 3D Hologram Table.

#### B. Experience:

- 1. Bidder should have undertaken Conceptualization, Content Creation, Curation, Designing, Execution of Interpretation Centres or Memorials or Museums or Experience Centres (permanent in nature) involving new age technologies like Augmented Reality, Virtual Reality, Gesture Based Simulation, 3D Hologram Projection Technology, Immersive Technology, etc. single client of Private/Government, with a minimum project cost as below:
- (a) Combined project value of INR. 45.00 lakhs or above from a single client (exclusive of taxes) (permanent in nature)- Single Project
- (b) Combined project value of INR. 25.00 lakhs to INR 45.00 lakhs from a single client (exclusive of taxes) (permanent in nature)- Two Project
- 2. Bidder Should have at least one complete Installation certificate/Work Completion Certificate of 3D Hologram Table from the client.

#### C. Registration & licenses

- a) The bidder should have the following:
  - i. Permanent Account no. under the Income Tax Act,
  - ii. Latest filed GST return form and valid GST certificate
  - iii. Latest filed and submitted Income Tax return from concerned Department.
  - iv. Copies of original documents defining the constitution of legal status, place of Registration and principal place of business, written power of attorney in the name of the signatory of the bid to all for the Bidder.

#### D. General criteria

- a. Bids from Joint Venture and/or Consortium are not acceptable.
- b. The intending bidders will have to visit the site of the proposed work at his/their own cost and survey the site before submitting the Bid.

#### I. Earnest Money Deposit:

The bid document must be accompanied by the Earnest Money Deposit of Rs. 3,00,000.00 (Rupees Three Lakhs Only) through Internet Banking from State Bank of India (SBI) or any other banks listed at SBMOPS on <a href="https://assamtenders.gov.in">https://assamtenders.gov.in</a> or NEFT/RTGS in case of offline payment from any Bank.

The EMD in any other form shall not be entertained.

#### II. Bid Evaluation

All evaluation process will be carried out by a Tender Evaluation Committee for evaluation of Technical bid and the Financial bid. The technically responsive bidders will qualify for the opening of Financial bid for the "Selection of Contractor for the Supply, Installation,

Commissioning and Construction of TEXMIN-AMTRON CPS 4.0 Center of Excellence within the Existing 3DPCOE at Tech City, Guwahati, Assam".

- a) The Tender Evaluation Committee will open all the Technical bids received (except those received late). In the event of the specified date of Bid opening being declared a holiday, the Bids will be opened at the appointed time and location on the next working day.
- b) After opening the envelope containing "Technical Bid" the amount, form and validity of the bid security furnished with each bid will be announced. If the bid security furnished does not conform to the amount and validity period as specified in the Appendix, the "Technical Bid" will be returned and their online financial bid will not be considered.
- c) The "Technical Bid" of only those bidders will be entitled for financial evaluation online whose technical bids are found responsive.
- d) During the financial bid evaluation, total cost of the project submitted online by each bidder will be consider.

#### III. Right to vary scope of work by AMTRON at the time of award:

AMTRON may at any time, by a written order given to the Bidder, make changes to the scope of the work as specified or award the work in phases. If any such change causes an increase or decrease in the cost of or the time required for the Bidder's performance of any part of the work under the Contract, whether changed or not changed by the order, an equitable adjustment shall be made in the Contract Value or time schedule, or both, and the Contract shall accordingly be amended. Any claims by the Bidder for adjustment under this Clause must be asserted within fifteen (15) days from the date of the Bidder's receipt of AMTRON's changed order.

#### **IV.** Split-up of Order:

AMTRON may split the Work order among the bidders in an equitable manner subject to matching of price by the qualified bidders of the technical bid in order to execute the project within the stipulated time frame.

#### V. Subcontracting:

The Contractor shall not appoint a subcontractor/affiliate to perform its obligations under this Contract without obtaining prior written approval of AMTRON and/or except for the purposes mentioned in this RFP. AMTRON's approval of a subcontractor/affiliate shall not constitute a waiver of any rights it may have based on the contractor's representations and warranties. The Contractor will be fully responsible for all acts and omissions of its subcontractors and affiliates.

Nothing in this Contract shall be construed to create any contractual relationship between AMTRON and any subcontractor or affiliate, nor any obligation on the part of AMTRON to pay or to ensure the payment of any money due to any subcontractor or affiliate.
